- I was asked 4 questions during my presentation of the canal dredging projects. Below are the questions and the City's responses:
- Question: Is the Northgate canal work behind Forest Trail completed? The adjacent property owner wants all debris removed from the area. This was a request made to you last month.

Answer: Yes. The cleaning of the ditch behind Forest Trail is completed. The inspector and project manager have left notes with the property owner and they provided

contact info to the property owner should he have any additional questions.

2. Question: When will the Thalia extension (Windsor Woods or Presidential Canal) dredging actually start and be completed? The status report keeps pushing the date out.

Answer: The Contractor is currently removing vegetation. The dredging equipment is scheduled to start working in the canal on February 26th. The Windsor Woods Canal Dredging project is scheduled to be completed by June 28, 2018.

3. Comment: Tell the surveyors not to throw cut vegetation into the canals.

Response: The surveyors were advised of the concern.

Stalking Defined

"a pattern of behavior directed at a specific person that would cause a reasonable person to feel fear." Therefore, when someone's actions can be clearly identified as intending to create fear in another, the stalker can be guilty of a class 1 misdemeanor or higher, according to Virginia Law code § 18.2-60.3. The key in reporting a stalker to law enforcement officials is conveying the level of fear his actions produce. The legal definition of FEAR IS NOT THE SAME AS THE DICTIONARY DEFINITION OF FEAR. For legal purposes demonstrating a reasonable level of fear would mean the victim has been forced to make adjustments in her behavior as a result of the stalkers actions; such as

THE PRINCESS ANNE PLAZA CIVIC LEAGUE WILL HOLD ELECTIONS AT THE REGULAR MEETING OF TUESDAY, MAY 8TH, 2018

Nominations will be accepted for the following offices and committees:

<u>PRESIDENT</u> shall preside at all Executive Board and membership meetings and shall have general supervision of all affairs of the League. By virtue of his/her office, the President shall be an ex-officio member of all standing committees and special committees. He/she may cast a vote at any League meeting (regular, special, or Executive Board) to break a tie.

<u>FIRST VICE-PRESIDENT.</u> In the event of a vacancy for President, the First Vice-President will step up to President and the Second Vice-President will step up the First Vice-President, and a new Second Vice-President will be elected; these officers to hold these positions for the unexpired terms of office. The First or Second Vice-President in that order shall assume the duties of the President in his/her absence. Specific duties of the Vice-Presidents shall be determined by the President and/or Executive Board, from time to time.

<u>CORRESPONDING SECRETARY.</u> The Corresponding Secretary shall conduct all correspondence of the League and, in the absence of the Recording Secretary, shall assume the duties of same.

TWO MEMBERS OF THE BOARD OF TRUSTEES. (Larry Dennis and Phyllis Elms) The duties of the Board of Trustees shall consist of participating as members of the Executive Board and serving as auditors of all financial records of the League. There should be such audits, made annually, and reports on them presented at the May meetings of the League.

<u>NEWSLETTER.</u> This committee shall issue a monthly publication, named The Civic League Ledger. It shall, at all times, reflect the objectives of the League, as set forth in the Constitution Article 2. Object. The Newsletter shall carry reports from League Officers, Committees, Delegates or members, in good standing. Articles from other organizations, such as PTAs, Garden Clubs, Recreation Center, Neighborhood Watch, and so forth, will be welcomed.

Local advertisements will be solicited and published, to help finance the cost of the Newsletter. The Newsletter will be distributed to all members, in good standing. The Newsletter will also be distributed to City Council members, CCO President, Public Information Office, Schools in the PAPCL area and Advertisers in the Newsletter.

<u>PROGRAM COMMITTEE.</u> This committee shall provide for appropriate speakers and programs for the regular monthly meetings, as desired or suggested by the membership.

<u>SOCIAL</u>. This committee will provide for social events desired and suggested by the membership, with the amount of money to be determined by the Executive Board.

DELEGATES TO THE COUNCIL OF CIVIC ORGANIZATIONS.

Delegates will attend the monthly CCO meetings. A report shall be given and/or Newsletter article, at the discretion of the Delegates.
